New Business

- Motion Saskatoon Waterski Club will receive an \$8000 hosting grant for being the host club for the 2022 Western Canadian Waterski Championships. Mike/seconded Cynthia discussion The Westerns Profit/Loss and overall budget, specifically for Competition-Excellence provided the basis for the amount recommended. There were purchases by WSWS for equipment to support the event that belong to WSWS, and are stored in the WSWS locker and added to inventory. The PSO is grateful to SWSC for hosting this prestigious event and the opportunity for our provincial athletes to compete in an RC event, many athletes for their first time. Carried.
- 2022 Budget Update The budget is on track to be balanced. The projected Revenue was very close to Budget. Expenses up to this point have been within budget expectations. Upcoming, there are some decisions pending related to expenses in the Excellence program based on their allocated amounts. MAP funding will be paid out in Oct. This year's budget has provided insight into planning for the next budget cycle for 2024's application due Oct. 15th, as certain amounts for items such as meeting expenditures need to be adjusted due to the reduction in costs as a result of online. Further cost savings in Capacity/Interaction are also realized with the use of the Wix platform. Also, Mike is exploring options for Audit costs, as the current expense is very high, and he is looking at options to reduce this amount. The Auditor has already been appointed for 2022, so this would be for the 2023 year and forward. These saving on the expenses in Capacity and Administration should provide for allocation to the Participation items in the budget if Revenue and self-help remain constant in the upcoming budget years. Len is working with SaskSport to better understand how to use the self-help and the possibilities for carry-over into future years for projects/programs/long term development.





- 2023 Budget \$17500 increase. Sask Lotteries has provided a one-time grant increase to our budget, due to reduced expenses and increased revenue in their funding model during the pandemic. Norm will coordinate ideas from the board to identify ways to maximize the impact of this increase to support the goals of the Association. He has asked for ideas from the board for this opportunity. Initial discussion provided topics such as Athlete Assistance increase for major events in 2023, Club Development and increasing membership, exploring ways to get the Cable system operational, and a combination of these with other ideas to maximize the effect it can have long term on our programs. Norm asked the board to continue to think about this and send ideas his way, and this will be on the agenda next board meeting.
- Grants SWSC and South SK have completed their Adaptive Grants for 2021 that were carried over. I have asked for an extension for 2 grants, one is an Adaptive Equipment Grant to support a Deaf and Hard of Hearing initiative, the second is the Jeux Canada Games grant to support the Cable park project. I have written 2 grants so far for 2023, one is a program grant to support a DHH program offering, the second is a marketing grant with Sask Tourism.
